#### **Unfinished Business:**

- Janis directed IR's to submit changes for Standing Rules if they saw a need for them.
- Condo offer (Rene) was discussed. It would be for 1 week on the beach in San Carlos, Mexico. An Ad Hoc committee (Jen G., Rene, Chris, Janis) will decide how far reaching the fundraiser will be, dates, and other details. Rene described the condo and specifics that needed to be announced or on flyer (about location, deposit (\$200 refundable), passport, not handicap accessible (stairs) and to be used within one year) and website can be viewed and winner would book through Rene. There is no expected amount to be raised, auction has raised \$3000-5000 for other groups.
