Ordered 10 more updated Group Handbooks AND 30 "The Twelve Concepts of Service". Met with two new IRs. Updated IR documents. Updated and emailed OA Intergroup binder Table of Contents to IRs. Tip of the month: Pray before you eat, pray before you shop and pray in the checkout line.

Unfinished Business:

- Second WSBC delegate. Neva nominated by Rene. Nancy K. seconded. No discussion. 14 Aye. Motion carries.
- Jen will not be able to attend Spring Assembly. Therefore IG will only have one representative.
- Policy motion to amend SEAZ policy 2/95 to read as follows:

"That all groups will operate autonomously and donate to Intergroup, Region and WSO at the group level. Intergroup will no longer be responsible for sending group contributions to Region and WSO. Intergroup may donate to Region and WSO a percentage of its income (from Special Events, 7th Tradition, etc.) after all Intergroup needs are met."

Neva introduced, Cheryl seconded.

Questions:

Susan C. - Is there a budget line item for this? Answer - yes.

Leigh – was the purpose of this motion to prevent duplication? Answer – purpose was to separate out what meetings were doing.

Adena (guest) – will IG be donating a fixed percentage? Answer – no. The amount to be donated depends on the IG expenses for the year. This is determined by the budget committee made up of representatives from various meetings.

- Telephone Committee motion #1 Remove the extension mailboxes on our CenturyLink service contract. (Note: Passing this motion rescinds Policy 09/03 in the SEAZ Policy Manual.)
 - Susan C. We can still leave a message or direct people to our website. Daily volunteer will still follow up within 24 hours.
 - Elise M. impact on budget is to save \$6.95/month.
 - We have a bilingual volunteer to record new message.

14 Aye. Motion passes.

- Telephone Committee motion #2 Add phone listing to the following white pages: Yuma, Safford, Bisbee, Benson and Patagonia. Viviane seconded. Since we have meetings in all those areas, our presence should be in each town's phone books. (Note: Passing this motion amends Policy 01/97 in the SEAZ Policy Manual.)
 - Adena Century Link will place the ads in the Dex phone books for 1/2 1/3 the cost of Dex Media. In addition, Century Link will give us a one month free offer for basic service (\$35.95 value) to have us stay with Century Link. They would not make any accommodation for our being a non-profit. Total cost would be \$23.75/month for all areas.
 - Nancy R. Affect on budget? Neva S. we have general funds and prudent reserve to cover the additional costs. If we cannot cover the costs in that manner, a fallback plan is to adjust the budgets of other committees who have not spent their allocations.
 - This will cause IG to go over budget for this year. Board will prepare a motion for a budget waiver to be presented at next month's IG meeting.

New Business:

- Vision and Goals #3 Attract and retain new members.
 - Yuma group is planning a PI event for next Fall/Winter. We will be working with them on the event and will provide newsletters and meeting lists. Nancy K. – create invitation for newcomers? Asked Yuma to publicize Tucson meetings?
 - Barbara A. and another member have created PIPO packets to distribute to hospitals.
 - Cheryl There are resources on the OA web site to guide members on how to carry the message, including the new "Carrying The Message" pamphlet.
 - o Adena L. proposed Anorexic/Bulimic workshop.
 - o Randi Z. Saddlebrooke health fair in October. Will get more information.
 - o Neva Falls to individual members to carry the message since there is no PIPO chair.
 - Connie There will be two upcoming tribal celebrations, one in April with about 300+ participants and one in September with about 400+ participants. OA will be represented. The Tucson Indian Center would like to educate their staff on OA. Coordinator is ill but will pick up again when she's feeling better. This should be added to the newsletter.
