Call to Order: At 11 AM by Emily R-S., Chair, instructed those in attendance on Zoom to mute/unmute and led the Serenity Prayer. Chris took attendance and 12 Steps and 12 Traditions read.

Minutes [Chris N]: The minutes from the April 18, 2020 IG meeting were accepted as submitted by Chris. Emily will grant access to the drive for the new members and IR's.

Treasurer's Report [Cheryl L.]:

- Our income for April was \$2,230.56. Our expenses were \$463.42. We had a couple of very lean months, but April and May have put our average monthly income back on track.
- The PayPal account is open and we have received several donations through it. Joy has put information about 7th tradition and PayPal on homepage of our website in the Announcements. She has also updated the form found through the link under "Donations" (on the left side or bottom of every page).
- I enabled Zelle on our bank account so that members whose bank subscribes to Zelle can make donations sending to the email "treasurer@oasouthernaz.org" and there are no fees. Members can enter their group number or other information in the "What's this for?" field on the review page. Most large banks are part of the Zelle network. I will be notifying group treasurers of this option. My credit union is not with Zelle, so I tried making a donation using the Zelle app and my debit card, but I received a notice that So AZ IG is a "small business and cannot receive money from debit cards at this time". I have not spoken to the bank about this.
- Since the libraries are re-opening, I will order the books we voted to put in the libraries.

Committee Reports

Region 3 Representatives/World Service Delegates' Report [Randi F. Sr. Delegate; Cynthia N. Jr. Delegate]:

The World Service Business Conference that was scheduled to take place April 21-26, 2020 was cancelled due to the global COVID-19 Pandemic. However, the delegates were asked to vote via e-mail on Trustee and General Service Trustees elections. Questions composed by delegates were asked of the nominees and answered. After reading through the information provided, all three trustees and two general service trustees were elected for a three-year term based on a majority vote. There is one vacancy left for a general service trustee, which has two years left on a three-year term. Per the bylaws, the Board of Trustees may or may not choose to fill the vacancy. This will be discussed at a board meeting later this month.

The delegates were also asked to vote on four literature motions, which consisted of:

- In OA, Recovery is Possible
- Temporary Sponsors Newcomers' First Twelve Days
- To the Young Person
- A Lifetime of Abstinence

All four motions to adopt the literature as it was presented was passed by a two-thirds vote. Each proposal was presented with 15 questions and answered by the Conference Approved Literature Committee. Again, we were asked to vote on the content of the literature as it was presented, and no amendments to the literature notions could be made at that time. This was a yes or no vote based on the integrity of the manuscript and its value to the entire Fellowship. I will now be serving on the Twelve Step Within Committee. Our initial meeting is scheduled for Saturday, May 9. As our meetings progress, I will bring back information on what our goals are for the Fellowship.

7th Tradition - PayPal ad hoc committee [Randi F.]

NOTES:

- 1. After discussion, we decided that PayPal will be the official platform for electronic payments.
- 2. We do not recommend putting button widget that comes with PayPal on the intergroup web site because it does not allow us to specify the group number.
- 3. There are two options for members. The member uses their own PayPal account to "Send to a friend" rather than "Paying for an item or service" and they enter treasurer@oasothernaz.org. There are no fees for choosing their bank account for the transfer, but there are fees for choosing their credit card. If they don't choose "Send to a friend", we pay fees. The member can also use Zelle or some other third party app but we're not going to complicate things by mentioning it. The process for using Zelle is actually very similar to PayPal.
- 4. The detail instructions have been updated to specify the fees that would be incurred under each option.
- 5. We should still encourage members to send donations to their group treasurer so they can disburse payments to intergroup, Region 3 and WSO.
- 6. It was suggested that we add a logo for the intergroup to our PayPal account. We liked the idea of using the one that was created for the convention (currently in draft) as a baseline and changing the text a little. The Intergroup Board approved using the modified logo for PayPal and the Intergroup website. We are awaiting drafts of the revised logo
