Treasurer's Report [Cheryl L.]: Our income for August was \$902.59. Our expenses were \$61.56.

- We have implemented the new policy to allow the Intergroup treasurer to accept and pass on donations for World Service and Region III. The August donations were \$133. \$79.80 for SoAZ Intergroup shows in the 6/30/10 Donations on the Income Statement. \$39.90 was sent to WSO and \$13.30 was sent to Region III. These amounts are included in the bottom section of the Financial Statement and will be deducted this month because that is when they were dispersed. So far this month \$500 has been received to be split 60/30/10.
- I emailed Budget Request forms to the Board and Committee chairs. Please fill them out and return to me by September 30. The forms are also on the Google Drive in the September folder. We will form a committee next month to work on a budget proposal for 2021.
