Minutes [Randi F]: The minutes from the May 2021 Intergroup meeting were accepted as presented by Randi F. The approved versions of the minutes will be in the Google Drive 06/2021 folder.

Logo Selection (first round): The 9 options were presented by Chris N. The text for option #9 could be modified if desired. All meeting attendees were eligible to vote. Top 3 vote getters were options 9 (13 votes, 5 wanted additional edits), 6 (4 votes including all three Sierra Vista meetings) and 4 (2 votes). These options will be re-voted upon during the "ongoing business" section of the meeting.

Treasurer's Report [Chris N.]:

- Full report is in the OA2021/06/2021 folder of the Google Drive. Our income for May 2021 was \$1,410.93. Our expenses were \$148.92. The checkbook and bank balances on 5/30/21 were \$15,178.85 with one outstanding check. The bank balance, checking account were in balance. An adjustment of \$141.15 had to be made in the spreadsheet to bring all three items into balance. This adjustment appears in the spreadsheet with the line item of "unknown discrepancy".
- The intergroup purchased a liability insurance policy effective 6/10/21. Marilyn B was informed and a copy of the policy was sent to her. However, she was just looking for a certificate. The TSW chair and all IRs should be informed as well.
- PO Box fees increased to \$146/year, which is \$21 over budget. A motion will be made at the next Intergroup meeting to adjust the budget accordingly.
- The Treasurer's laptop has been set up. Steep learning curve due to new OS and new software.
